ADDRESS

All students on student visas must keep SCIC informed of their current contact details including address, email address and phone number throughout their period of enrolment. This is a condition of their student visa. The student must notify SCIC of any change of contact details within seven days of this change occurring

ACCOMMODATION

SCIC can arrange placement in homestay accommodation (through a homestay agency) and offer advice on finding non-homestay accommodation.

Students under 18: All students under 18 years of age or enrolled in the HSP course who do not live with a parent, relative or legal guardian approved by SCIC must live in an SCIC-approved homestay.

BOOKING AIRPORT TRANSFER

Student notifies SCIC that the require airport pickup at the time of application and make accommodation payment after Offer Letter is issued.

Once monies have been received it is the student’s responsibility to advise SCIC of their flight details and arrival times at least 48 hours before arrival. If advice is given after this, or the student misses their flight or connecting flight and does not advise SCIC via email immediately, SCIC will charge a a \$100 late accommodation notification fee on top of the amount already paid for the pickup.

COST OF LIVING IN AUSTRALIA

International students seeking a student visa are required to demonstrate and/or declare that they have access to sufficient funds to live for the duration of their student visa. Indicative amounts change according to the economic conditions prevalent in Australia. As of 02 October 2023, yearly amounts are: student/guardian AUD\$21,041; partner/spouse AUD7,362; child AUD3,152.

SCHOOL-AGED DEPENDANTS

Accompanying students to Australia will be required to enrol at school and pay full fees if they are enrolled in either a Government or non-Government school.

OVERSEAS STUDENT HEALTH COVER (OSHC)

OSHC is compulsory health insurance for students on a student visa. The insurance is valid (and must be paid to include) the period from the first day you arrive in Australia until the end of your student visa. It covers GP and hospital care, some prescription medicines & emergency ambulance.

PERIOD OF COVER

Start date

For applicants outside of Australia, the student should have OSHC that begins on or before the date of their visa grant. If you are granted your Student 500 visa and you enter into Australia on a date that is before the date your health insurance kicks in, you will be in breach of Condition 8501 which will make you liable for visa cancellation and hurt your visa history.

End date

The end date for OSHC should be until the end of the visa holders intended full period of study. In the situation where the student is taking on a packaged course, the end date for their OSHC should be at the end of their entire packaged or combined course.

All courses are delivered entirely through face-to-face, classroom-based instruction at SCIC’s campus on Level 3, 233 Castlereagh Street Sydney NSW. Students can enrol in a maximum of four consecutive courses (one after the other). The courses include:

AN EXPLANATION OF COURSES, SATISFACTORY ATTENDANCE and COURSE PROGRESS

Students can begin any course except EAP and Cambridge Advanced on any Monday throughout the academic year. Students are tested upon commencement at SCIC and placed in the appropriate level. SCIC courses and course levels are all 12 weeks in duration. Student can move to a higher course level if they meet course requirements:

- They have completed 12 weeks of a course/ course level
- They demonstrate satisfactory course progress
- The demonstrate minimum attendance requires of no less than 80% attendance.

SATISFACTORY COURSE PROGRESS

A condition of a student visa is maintaining satisfactory course progress. Students demonstrate they are making satisfactory course progress by their performance in regular tests. All tests, in all courses, are based on material taught in class in that particular week. The EAP and HSP courses also include assignments as a part of the student’s assessment.

SCIC deems a student’s attendance to be unsatisfactory if they do pass the required number of assessments as determined by each course’s progress requirements.

If a student demonstrates unsatisfactory course progress, SCIC will notify students of its intention to report them to DHA for breach of student visa conditions. Students have the option to appeal SCIC’s decision to report for unsatisfactory course progress.

SATISFACTORY ATTENDANCE

A condition of a student visa is having satisfactory course attendance. SCIC will record a student’s attendance for all contact hours of each course in which they are enrolled. Each Confirmation of Enrolment a student is issued represents one course. SCIC deems a student’s attendance to be unsatisfactory if they do not attend 80% of their total course class hours.

Students have demonstrated unsatisfactory course progress if attendance falls below 80%.

SCIC will notify students of its intention to report them to DHA for breach of student visa conditions. Students have the option to appeal SCIC’s decision to report for unsatisfactory attendance.

STUDENT TRANSFER

Transfer to another provider

A student is permitted to transfer to another provider if limited circumstances. Generally a student cannot transfer to another education provider until the student has completed six months of their course and SCIC has approved their application for transfer.

COMPLAINTS AND APPEALS

SCIC has a process in place for students to register complaints and to appeal decisions made that can affect their student visa.

If a student is advised that SCIC intends to report them to the Australian Government for misconduct, breach of student visa conditions or non-payment of fees, they can access SCIC’s internal appeals process to review this decision.

If the decision made by SCIC is upheld, the student many choose to access an external appeals process by contacting the Commonwealth Ombudsman). Only after the Ombudsman upholds the decision will SCIC notify the Australian government and a Section 20 breach notice will be sent to the student and/or their legal guardian via email.

NOTE: If a student is under 18 years of age, that student’s legal guardian and/or parents will be invited to participate in all discussions with students about course progress/attendance; the deferral, suspension or cancellation of that student’s course; or a complaint/appeal by that student.
